Meeting called to order at 8:00 am by Chairman Richard Peterson.

June Board Minutes:

A motion by John Larson, seconded by Roger Bongers to approve the June board minutes as written. All aye. None opposed. Motion carried.

B. DNR Well Observation Agreement - action:

A motion by Roger Bongers, seconded by Gene Kuntz to approve the DNR Well observation agreement for fiscal year 2026. All aye. None opposed. Motion carried.

C. 2026 Budget - action:

District Manager reviewed the 2026 draft budget, which was submitted to Rice County on July 8th. Final budget will be presented for approval in December. The District Manager will present the draft budget to the county board later in July.

A motion by Roger Bongers, seconded by John Larson to approve the 2026 budget as presented. All aye. None opposed. Motion carried.

D. Conservation Building volunteer opportunities during fair - information:

The Rice County Fair runs July 16th to July 20th, 2025. Rice SWCD always has an information booth det up in the Conservation Building. A sign-up sheet for volunteer opportunities to staff the booth was passed around at this meeting.

E. Edward Jones CD expiring July 2025 - action:

The 12-month Edward Jones CD, valued at \$52,000.00 is set to expire in July. The District Manager recommends renewing the CD for another twelve months at 4% interest. The CD can only be whole numbers.

A motion by Gene Kuntz, seconded by John Larson to approve renewing the Edward Jones CD of \$54,000.00 for 12 months at 4% interest, with the remaining interest to be deposited back into the checking account. All aye. None opposed. Motion carried.

F. Planning communication letter for 2024 audit - informational:

The planning communication letter is generated by the audit company of Peterson Company LTD, certified public accountants, with whom the Rice SWCD has contracted to perform the 2024 audit. This letter spells out what the accountant's responsibilities are as well as the responsibilities of the Rice SWCD.

G. Matt Purfeerst 2025 WAGZ-RC-01, WASCOB - \$3,679.23 - action:

This contract is for a water and sediment control basin located in a high priority area of the Zumbro river watershed.

CSP:

FY25 Sign Up 1 Deadline is past, we are taking applications for sign up 2

EQIP:

- ⇒ EQIP FY26 Sign Up 1 deadline announced for August 1 this is months earlier than in the past.
- ⇒ All IRA applications from this year on hold indefinity some have been selected to be funded in other non IRA funding pools. It looks like this is the only way they will be funded going forward

CRP:

- ⇒ Still waiting to hear what applications have been chosen from first sign up
- \Rightarrow 2nd sign up is open until Aug 31st 2025
- ⇒ We are beginning year 3 and expiration spot checks that will continue though the summer.

WETLAND/HEL:

- \Rightarrow Rice County has 23 requests awaiting HEL determination for new land from the compliance team
- ⇒ Rice County has 33 requests awaiting a certified wetland determination from the compliance team

Acreage Certification

July 15th is the reporting deadline, so please get in and get it done ASAP!

COC Elections - Nomination Period Opens June 16, 2025 and ends August 1, 2025

- Must reside in the Local Administrative Area (LAA) and be an eligible voter in the LAA to be an eligible candidate.
- Rice County LAA 1 is up for election
 - o Erin, Forest, Webster, Wheatland

2023/2024 Supplemental Disaster Assistance

- The American Relief Act of 2025 signed into law on Dec. 21, 2024, provided funds toward disaster recovery assistance.
 - Emergency Commodities Assistance Program (ECAP)
 - Signup open now through August 15, 2025.
 - Applications will be pre-filled with 2024 certified acreage for eligible commodities.
 - Emergency Livestock Relief Program (ELRP) for Drought and Wildfire
 - ELRP payments will be made to livestock producers who have an approved 2023 and/or 2024 Livestock Forage Program (LFP) application on file for grazing losses due to eligible droughts.
 - Emergency Livestock Relief Program (ELRP) for Flooding
 - Provide assistance for losses due to flooding, currently requires more time due to software changes.
 - Target sign-up date of August 18, 2025
 - Supplemental Disaster Relief Program
 - Provide assistance to producers for necessary expenses due to losses of revenue, quality or productions of crops due to weather related events in 2023 and 2024.
 - Target sign-up date of July 7, 2025, for indemnified losses
 - Target sign-up date of September 15, 2025, for uncovered losses

New Business

Conservation Reserve Program (CRP)

- At this point, we still have not heard anything on acceptance of offers submitted during the first batching period ending June 6, 2025.
- Second batching period for continuous CRP signup 63 offers submitted after June 6, 2025, has a deadline of July 31, 2025.
 - We are unaware if any offers will be accepted from this batching period.
 - It all depends on the number of acres available after the acceptance of offers during the first batching period
- Additional details will be provided in the near future
